

# **FOREST EDUCATION & TRAINING , PUNE**

## **IMPORTANT ACTIVITIES OF FOREST EDUCATION CIRCLE.**

In Maharashtra, there are 2 forest training colleges and 3 training schools providing long term and short term trainings to frontline staff viz. Foresters and Forest Guards. These centres are located at Chandrapur, Chikhaldara (district. Amravati), Pal (district Jalgaon), Jalna and Shahapur (district Thane). These colleges/schools also conduct refreshers courses every year for Forest Guards, Foresters and Range Forest Officers.

Brief details about the infrastructure and training facilities available at these centres are given below –

### **CENTRAL FOREST RANGERS COLLEGE, CHANDRAPUR**

- Established in 1960
- Present capacity – 150
- Administrative building -1, training hall -3, hostel building-1, ladies hostel-1, staff quarters-70, library-1, computer room-1(20 computers), GPS -12, LCD projector-3.

### **MAHARASHTRA RANGERS TRAINING COLLEGE, CHIKHALDARA, DISTRICT AMRAVATI.**

- Established in 1974
- Present capacity –100
- Administrative building -1, Training hall -2, Hostel building-1, Staff quarters-57, Library-1, Computer room-1, GPS- 10, LCD projector-3.

### **FOREST GUARDS TRAINING SCHOOL, JALNA**

- Established in 1985
- Present capacity –120
- Administrative building -2, Training hall -2, Hostel building-2, Staff quarters-39, Library-1, Computer room-1(20 computers), GPS- 10, LCD projector-3.

### **DADASAHEB CHAUDHARY FOREST TRAINING SCHOOL, PAL, DISTRICT JALGAON.**

- Established in - 1968
- Present capacity –100
- Administrative building -1, Training hall -2, Hostel building-2, Staff quarters-23, Library-1. Computer room-1(20 computers), GPS-10, LCD projector-3.

### **FOREST GUARDS TRAINING SCHOOL, SHAHAPUR, DISTRICT THANE.**

- Established in 1963
- Present capacity –100
- Administrative building -1, Training hall -2, Hostel building-4, Staff quarters-16, Library-1. Computer room-1(20 computers), GPS-12, LCD projector-3.

State forest academy of development, administration and management is coming up at Kundal ( District Sangli). The different building construction activities are in progress at Kundal. There is a proposal of 62 posts of various cadres for Kundal academy, out of which 23 posts are sanctioned by government of Maharashtra. The sanction for the remaining 39 posts is awaited.

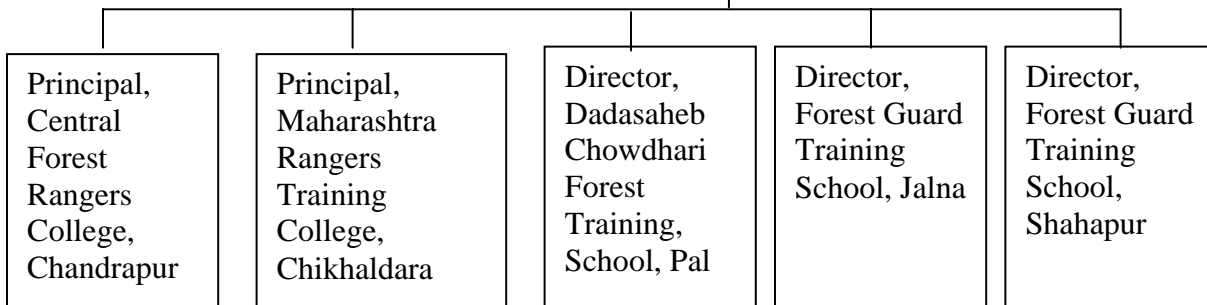

The syllabus for Forest Guards' training includes important subjects like Silviculture, Soil and Moisture Conservation, Watershed Management, Forest Policies, Forest Protection, Forest Laws, Wildlife Management and Wildlife Acts, Bio-diversity Act, Eco-tourism, Forest Botany, Accounts, Labour Laws, Forest Utilization, Forest Survey and Engineering, Joint Forest Management etc.

Syllabus for Foresters induction training includes Soil and Moisture Conservation, Silviculture, Entomology, Forest Protection, Forest Botany, Forest Survey, Human Resource Development, Accounts, Forest Laws, Labour Laws, Forest Policies, Joint Forest Management, Forest Development Agency etc.

Besides long term regular training courses large number of refresher courses for Forest Guards, Foresters and also Range Forest officers have been conducted in all the five centres. These courses are funded by Director, Forest Education, Ministry of Environment and Forest, Govt. of India, Dehra Dun and through State Plan funds. These courses include important subjects and Forestry issues like Wildlife Management, Man-Animal conflict, Forest Development Agencies and its working, Wildlife Acts, Forest Protection issues, how to control Forest fires, Personality development, Medicinal plants, Organic farming, Nursery technology, Bio-diversity, use of G.P.S., use of computer in forestry, Forest Utilization, Forest Policies, Forest Conservation Act etc.

Large number of clerks and Accountants are also exposed to short term trainings of one week in these five colleges and schools to sharpen their skill in official matters accounting and use of computers etc.. The departmental exam. of clerks and accountants is also conducted by this circle every year.

During the year 2010-11, total 15 number of two week refresher courses sponsored by Director, Forest Education, Dehra Dun for Forest Guards and Foresters were conducted. Besides, 7 number of refresher courses of one week duration on Forest Rights Act, 2006 for Forest Guards, Foresters and Range Forest Officers, and 12 number of refresher training

programmes for clerks and Accountants were conducted from the funds available under State Plan.

During the last four years, following short-term courses were conducted.

## **ACTIVITIES UNDER JICA PROJECT**

Maharashtra has been selected as one of the States to implement JICA funded Project. Brief description about JICA funded Project, activities to be carried out under the Project and works done so far in this project have been given as below-

1. Name of the Project : Capacity Development for Forest Management and Training of Personnel
2. Objectives of the Project : To improve training environment for frontline staff through the rehabilitation of State Forest Training Institutes and through capacity building of frontline forest staff putting emphasis on Joint Forest Management (JFM), thereby strengthening human resource development for sustainable forest management.
3. Project Period : 2008-09 to 2013/14 (5 years 3 months)
4. Project Cost  
Rs. 225 crores of which Rs. 206.40 crores will be procured by Central Government from JICA as loan with no burden on the States. The remaining amount of Rs. 18.60 crores of the Project for meeting out administration cost and VAT will have to be met by Central Government and the State Government.
5. Implementing States  
Maharashtra has been selected as one of the States for the implementation of the project.
6. Activities to be done under the Project
  - i) Revision of Training guidelines
  - ii) Preparation of sample course materials and teaching notes
  - iii) Rehabilitation of Training Colleges/Schools of the State /Preparation of State Training Improvement Plan.
  - iv) Training of Master Trainers
