

1. Post Graduate passed with a minimum. 60% aggregate marks from a recognised University in Wildlife Biology/ Ecology/ Forestry and Environmental Science.
2. Age Limit- Min. 21 years and Max. 40 years as of 31/10/2025.
3. Candidate must be able to read, write, speak and understand Marathi/English/Hindi languages.
4. Knowledge of camera trapping, wildlife census and basic computer handling is a must.

Desirable: Experience in camera trapping exercise, Animal abundance, density estimation and occupancy sampling, Line transect data collection and analysis, Wildlife data management, Statistical analysis, etc. Candidate having experience of working with the Forest Department/ WII (Wildlife Institute of India, Dehradun)/Wildlife monitoring activities will be given preference.

Work Description-

The Wildlife Biologist will be responsible for regular camera trapping, monitoring wildlife movements and behavior, conducting carnivore sign surveys and line transect sampling, and analysing ecological data. The role includes preparation of scientific reports, scat collection and analysis for research, and providing technical support to the Rapid Response Team (RRT) during wildlife rescue operations. The position requires strong field skills, data interpretation ability, and commitment to wildlife conservation and management activities

Terms and conditions-

1. Computer knowledge is must for the above posts.
2. Candidate should have proficiency in both Marathi and English; he/she should have skill to carry out correspondence in both Marathi & English languages.
3. The applicant should not have criminal tendencies or background. If found the applicant will be dismissed immediately.
4. Dy. Director Nawegaon Nagzira Tiger Reserve, Sakoli will be the Headquarter for the above posts. The selected persons will be required to work in the field of Nawegaon-Nagzira Tiger Reserve, at same time he/she will cater his/her services to Gondia, Bhandara Forest Division and other areas as per the directions of Field Director Nawegaon-Nagzira Tiger Reserve and Deputy Director Nawegaon-Nagzira Tiger Reserve.
5. If all the qualifications of the eligible applicants for a post of Wildlife Biologist are found to be the same, preference will be given to the applicant in the jurisdiction of Nawegaon-Nagzira Tiger Project Gondia.
6. Contract employees will be paid on emolument basis after completion of one month.
7. Dy. Director NNTR, Gondia reserves the right to decrease monthly emolument, if non performance or delay in the work is observed.
8. In case of financial loss to the Government due to negligence of the contractual employees, the compensation will be recovered from the employees.
9. If the Dy. Director NNTR, Gondia satisfied with the work after the expiry of 11 months of the contract, the contract may or may not be extended.
10. **These posts are not created by the Government of Maharashtra. If applicant is selected for this post, he/she does not have any claim for the post of government establishment or the right to remain in the permanent service.**
